## **Driving Directions to the Morsbach Tree Farm:**

**\* The Cazenovia Community Center is located on North Street in Cazenovia**

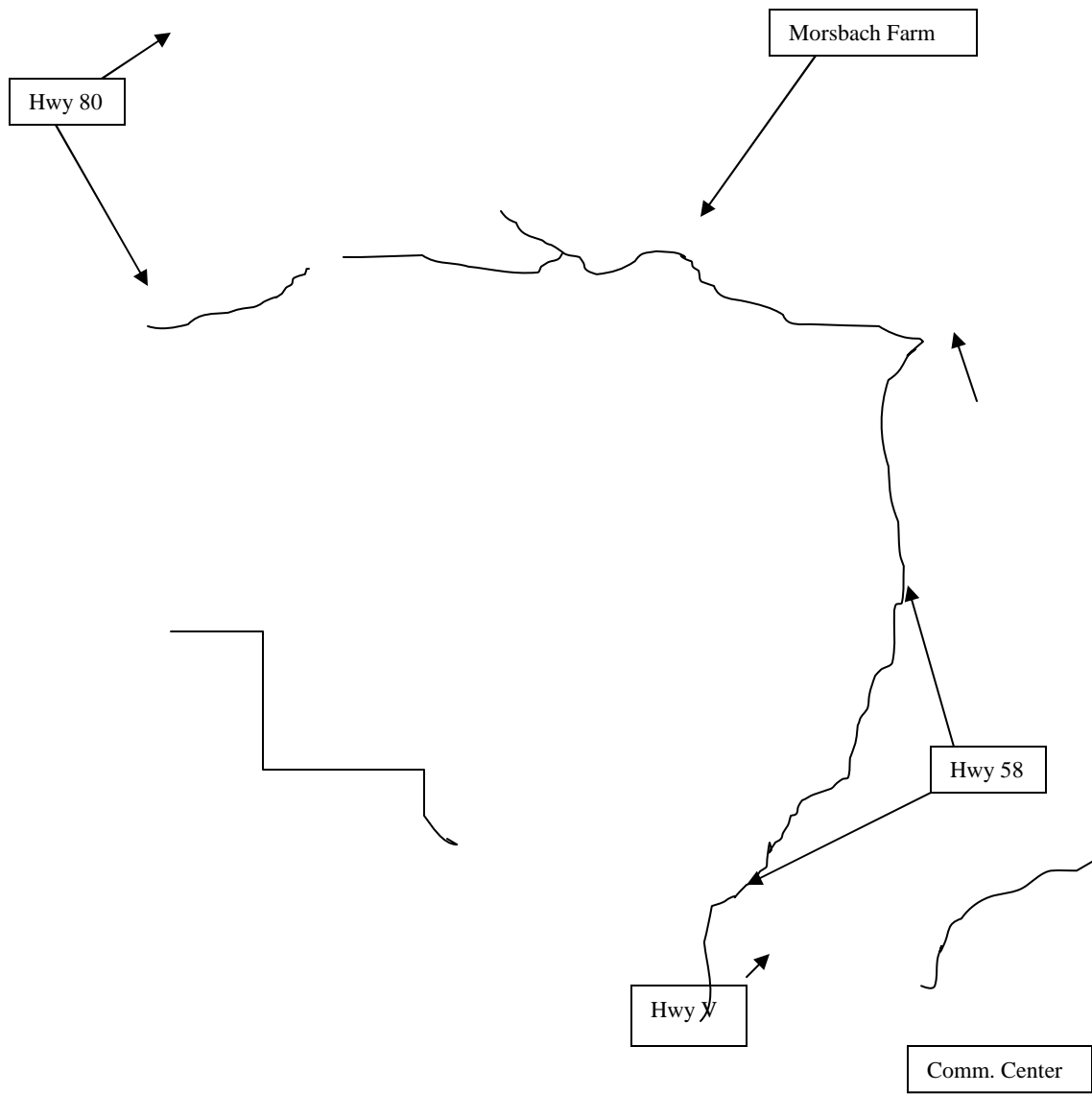
**From Richland Center:** Take Hwy 14 east 3 miles, turn north onto Hwy 58, travel approx. 17 miles to Cazenovia.

**From Cazenovia:** Take Hwy V to the west approx. 2.5 miles, turn right onto Morsbach Ln., Property is at the end of Morsbach Ln.



**From the West:** Take Hwy 80 north to Hwy CC, which is approx. 3 miles north of Hub City, turn right on CC and travel east for 5 miles, turn onto Hwy V to the east and travel 1 mile to Morsbach lane.

**From the North:** Take Hwy 80 south to Hwy V, which is in Vernon County, 2 miles north of county line. Travel east on Hwy V approx. 8 miles to Morsbach Ln.
